#### Fee Due Dates:

- Fees are payable in advance ("upfront") for each month and must reflect in Kay-Dee's bank account by the first (1st) of each month.
- On enrolment and/or the first (1st) day of attendance of your child, the fees due for the month in which your child starts must be paid in advance (upfront"), pro-rata if applicable, and thereafter in full on the first (1st) of each month following.

# Deposit (applicable to foreign parents only):

- A once-off <u>deposit</u> equivalent to one (1) month's fee may be applied at the discretion of Kay-Dee Educare Management, to be paid in advance ("upfront").
- The deposit will be <u>refunded</u> in the last month of the required written notice period.
- The deposit may not be used in lieu of payment and will only be <u>refunded</u> once all payments due have been settled.

### Discount:

A discount will be given at the principal's discretion on the fees of the second (2<sup>nd</sup>) child, and any subsequent children that the family has in the school at the same time.

## **Development Levy:**

- We charge an R50 development levy billed quarterly for each child per family in the last month of each term, i.e. March, June, September and November.
- This levy is used for new infrastructure projects and replacement or refurbishment of existing infrastructure.
